Tracks current auditor(s) of record. Key data points include current auditor and auditor tenure.

### Financial Restatements

Tracks corrections of errors (disclosed in English) affecting the financial statements due to clerical error, misapplication of accounting standards, or fraud (collectively "restatements").

### Key Audit Matters

Tracks individual KAMs disclosed in English, normalizes the topic, pulls the text of title and description, and the auditor's response.

### Transparency Reports

Tracks Transparency Reports published annually by EEA, UK, and Switzerland-located audit firms and the normalized names of all entities disclosed on each firm's report.
